INSTRUCTION FOR VENDOR REGISTRATION :-

1. Manufacturer/Suppliers are requested to submit their interest for manufacturing & supply of individual items along with the capacity of Plant & Machineries.
2. Vendors must clearly indicate the item / items (in VRR Form) for which they seek for registration. Vendors should apply in our **OFB online Vendor Registration** for our consideration and data submission as per procedure. (<https://ofbindia.gov.in>.)
3. Alternately, VRR Form may be downloaded from the website <https://www.ofbeproc.gov.in> in case of any difficulties in applying through online vendor registration.
4. Interested Vendors must submit the Expression of Interest for Advance Vendor registration on or before **21-08-2017**. Also, One set of hard copies of the same to be submitted along with all relevant & supporting documents to HAPP, addressed to **The General Manager, Heavy Alloy Penetrator Project, Trichy - 620 025, Tamil Nadu by Post.**
5. Vendor Registration fees Rs.2000/- for Small scale industries and Rs.5000/- for medium & large scale industries is applicable. Vendor registration fees as applicable to your organization is to be submitted along with the VRRF.
6. Capacity verification (both desk verification with the help of documents submitted and online verification) will be carried out by technical team of HAPP to verify your capacity & capabilities as per the decision of competent authority. In case of insufficiency, Your offer will be ignored.

7. Mandatory details & requirements:

- a) Filled VRR Form, ISO certification, Valid License for Production, Valid TIN / GST registration certificate of company, NSIC / MSME registration certificate.
 - b) 3 Years of Income Tax Returns, Annual Turn over & Audited Balance Sheet for last 3 years
 - c) List of Plant and Machinery, Laboratory Equipments, Testing facility, Raw material sources,
 - d) List of Man power employed and Electric power details
 - e) List of regular customers, outsourcing supplier/customer if any, product details and any other particulars pertains to the items for registration.
8. If, your organization is already registered for any of the item with any of the ordnance factory, the registration certificate may be submitted for consideration of Vendor registration at our factory.
9. Vendor should note that this is only for Registration of vendor and Tender will be issued only for those vendor who will qualify during Capacity verification done by our assessment team.
10. The quantity mentioned in the EOI is only tentative requirement, it may vary depends on our targets. For items SI.No.4 to 20, Inspection will be done by Naval Armament Inspectorate or Trichy or his authorized representatives.
- 11. Firm should go through the Drawing and Monitoring Instruction Enclosed in Annexure 'A' and 'B' before submitting their interest for Vendor Registration.**
